Old English Southdown Babydoll Lamb Reservation with Non-Refundable Deposit Contract

The purchaser agrees to not hold Julie Lyon or Lyon Acres liable for any negative consequences that may occur due to the purchase of an animal from Julie Lyon/Lyon Acres. All animals are healthy to the best knowledge of Julie Lyon when sold. Once an animal leaves Lyon Acres it may not return for biosecurity purposes. All sales are final. A nonrefundable deposit is due immediately to reserve your lamb(s).

<u>2024 Base Prices:</u> Registered Ewe Lamb RR/QR: \$1,025. Unregistered Ewe Lamb RR/QR: \$1,000. Registered Ram Lamb RR: \$1,025. Unregistered Wether Lamb QR/RR: \$450.*	Lambs will be individually priced. The prices above are the base prices. Occasionally, a lamb may have exceptional qualities that justify an altered price. *A \$25 discount will be applied to purchases of 3 or more wethers. \$25 off for every wether after the second. (Lambs must be purchased & picked up at the same time.)

To reserve lambs, a nonrefundable deposit must be received. Lambs are not reserved until the deposit has been received. The deposit required for ewes and rams is \$200 per lamb, and \$100 per wether. The remaining balance is to be received either before the date of pick up via check with sufficient time for the check to clear (2 weeks), or in cash the day of the pick up. Checks will not be accepted the day of pick up. No exceptions. You may also pay via Zelle. All lambs must be picked up from Lyon Acres in Brush Prairie, Washington. If the lamb(s) you request cannot be supplied, your deposit will be refunded to you. If you need a vet certificate to cross state borders, you will be responsible to pay those fees before the vet appointment. Contact Julie for an estimate.

Qualifying lambs will be registered with NABSSAR. Color does not alter price. Ram lambs will be selected first, before wethers, to ensure that the best genetic traits are passed onto future generations of Babydoll sheep.

All sheep must have another sheep to live with at all times. They are flock animals; alone they will fail to thrive. Other species are not sufficient substitutes for a sheep companion. If you currently do not have sheep, you will need to purchase 2.

I reserve the right to not sell an animal to any individual at any time. I love our animals and want them to have good lives once they leave my farm. Additionally, as the breeder I will choose which lambs I want to retain before fulfilling requests on the waitlist.

Upon recommendation by my veterinarian, lambs will not receive any CD&T shots until they are at least 3 months of age. Research shows that vaccinations prior to then are unnecessary due to the antibodies they have from their mothers. Therefore, the lambs may not have had any vaccinations at time of pick up due to their age. Lambs will be dewormed at time of weaning or prior to leaving the farm.

I will do my best to make sure both testicles are in the sack when the band is placed. I am not responsible if a testicle slips up. If you prefer to have a veterinarian do a surgical castration, I can arrange this, but all costs will be paid in advance by you. Info below will be used for registration paperwork.
